3. Program description

The doctorate in Architecture provides a space of training and advanced high-level research not only for those from the academy, but also for those who deal with architecture in the context of professional practice to whom this course presents the possibility of deepening knowledge and developing skills in the area of Architecture.

The thesis can integrate practical work of the project in architecture as a form of advanced research, as a context of scientific design driven research.

The course is intended to work within an international context, empowering students to work in a high academic level in a global competitive; Provides transdisciplinary knowledge on conceptual, formal and practical issues, on critical thinking, in planning and accomplishment works such as context landscape, in a comprehensive way, as cultural heritage (monumental, industrial, urban, architectural and landscape) in a more specific way with research application.

Having in mind the value of a cultural approach to architecture, grounded with technical skills, its is recognised relevance and in a wide range of areas. Notwithstanding such scope, more specific domains of advanced architectural skills are identified, especially in a "research by design" approach, such as:

9. General conditions of access and admission

i Legal conditions for access to the cycle of studies leading to the doctorate (doctor) degree (Ph.D.degree)

Those who meet the following conditions may apply to the cycle of studies that leads to the doctorate (doctor) degree (Ph.D.degree)

- Holders of the master degree or legal equivalent;
- Holders of a bachelor degree who have a particularly relevant academic or scientific curriculum
 vitae that is recognized as attesting the capacity to carry out this cycle of studies by the
 relevant scientific body of the higher education institution they wish to be admitted to;
- Holders of an academic, scientific or professional curriculum vitae that is recognised as
 attesting the capacity to carry out this cycle of studies by the relevant scientific body of the
 higher education institution they wish to be admitted to.

ii Specific admission conditions

Candidates to the doctorate programme are admitted as:

- 1. Those that prove to have a masters degree in architecture or equivalent area of studies;
- 2. Those graduated in architecture or in an equivalent area of studies, with at least a fulltime five years curricula in the university, or an equivalent curircula when coming from a foreign degree of studies;
- 3. Those who have either a scholar, or a scientific, and professional curriculum in the area of architecture that is evaluated as being relevant by the IIFA Scientific Council.

 - Professional Experience in the area of the program or related fields: 20%
 - Artistic Experience or Portfolio / Artistic Dossier in the area of the program: 20%
 - Participation in research projects: 20%
 - Scientific publications: 20%

 - Motivation and commitment: 60%

The application must include a letter of motivation stating the reasons for the application in an objective manner.

The level of knowledge of Portuguese and English must be explicitly stated in the CV.

Depending on the number of applications, there may be transfer of vacancies from the international students applications to the European Union students applications or vice-versa.

Depending on the number of applications, places may be transferred between the competition for international students and the competition for students from the European Union.

12. Tuition fee

- Candidates with nationality of European Union countries: 1 500,00 €
- Candidates without nationality of European Union countries: 2 500,00 €
 - Annual Tuition fee for international students with merit scholarship: 1 500,00 €
 - Annual Tuition fee for international students with cooperation and development scholarship: 1 700,00 €

In the admission year, all students with international student status who have a grade C higher or equal to 16 ($C=0.6 \times \text{undergraduate average} + 0.4 \times \text{master's average}$, both averages on the scale 0-20), benefit from the tuition fee for international students with merit scholarship and all students from PALOP countries benefit from the tuition fee for international students with cooperation and development scholarship.

In the following years, to keep the merit or cooperation and development scholarship, the student has to meet the conditions stipulated in article 22 of the Academic Regulations of the University of Évora and the results are published until October 31 of each academic year, without the need to apply for the scholarship.
