#### 3. Program description

The PhD Programme in Psychology is aimed at a wide range of professionals interested in research and advanced and sustained training in the various 'areas of Psychology. Psychology is a scientific and disciplinary area consolidated in the University of Évora, having its teaching staff relevant research in line with one of the anchor areas of this university: Life pathways and well-being.

It aims to develop skills for the exercise of scientific research in Psychology, leading to the elaboration of original scientific work of recognized quality that contributes to the advance of knowledge in Psychology. Thus, more specifically, it is intended that students deepen their theoretical and methodological knowledge in the scientific field of Psychology which will enable them to carry out autonomous research in this area of knowledge and the development of skills to, in a knowledge-based society, promote scientific, technological, social and cultural progress in the academic or professional context.

#### 4. Career opportunities

The professional opportunities are related to the skills to be acquired throughout the course (and that take into account the mandatory requirements for obtaining the doctoral degree established in Decree-Law No. 74/2006 of 24 March), highlighting the following: 1) prepare, design, carry out and evaluate scientific research; 2) develop skills to communicate the results of the research carried out before the scientific and technical community and society; 3) innovate and undertake in Psychology.

Those who meet the following conditions may apply to the cycle of studies that leads to the doctorate (doctor) degree (Ph.D.degree)

- Holders of the master degree or legal equivalent;
- Holders of a bachelor degree who have a particularly relevant academic or scientific curriculum
  vitae that is recognized as attesting the capacity to carry out this cycle of studies by the
  relevant scientific body of the higher education institution they wish to be admitted to;
- Holders of an academic, scientific or professional curriculum vitae that is recognised as
  attesting the capacity to carry out this cycle of studies by the relevant scientific body of the
  higher education institution they wish to be admitted to.

In the year of entry, all students with international student status who have a C grade greater than or equal to 16 (C=  $0.6 \times bachelor's$  degree average +  $0.4 \times bachelor's$  degree average, both averages on a scale of 0-20), benefit from the tuition fee for international students with a merit scholarship and all students from PALOP countries benefit from the tuition fee for international students with a cooperation and development scholarship.

In subsequent years, to maintain merit or cooperation and development scholarship, the student must meet the conditions stipulated in article 22 of the Academic Regulations of the University of Évora, and the results will be published by 31 October of each academic year, without the need to apply for the scholarship.

Depending on the number of applications, there may be transfer of vacancies from the international students applications to the European Union students applications or vice-versa.

#### 11. Tuition fee

- Candidates with nationality of European Union countries: 1 250,00 €
- Candidates without nationality of European Union countries: 2 500,00 €
  - Annual Tuition fee for international students with merit scholarship: 1 250,00 €
  - Annual Tuition fee for international students with cooperation and development scholarship: 1 450,00 €

In the admission year, all students with international student status who have a grade C higher or equal to 16 (C=  $0.6 \times 10^{-2}$ ), benefit from the tuition fee for international students with merit scholarship and all students from PALOP countries benefit from the tuition fee for international students with cooperation and development scholarship.

In the following years, to keep the merit or cooperation and development scholarship, the student has to meet the conditions stipulated in article 22 of the Academic Regulations of the University of Évora and the results are published until October 31 of each academic year, without the need to apply for the scholarship.
