3. Program description

The aim of this micro-accreditation course is to develop applied knowledge of phytotherapy to determine the importance and current interest of herbal medicines.

4. Objectives

The aim of this course is for trainees to acquire technical, scientific and research skills, applied to handling and use of herbal health products, in order to assess quality and efficacy and to develop skills and critical thinking for the correct counselling of medicinal plants and herbal health products.

5. General conditions of access and admission

i General conditions

Be over 18 years old and resident permit. If you do not have Portuguese nationality, you must have a residence permit and tax payer number .

ii Specific admission conditions

The course is aimed at graduates and masters in pharmaceutical sciences and other health professionals in the field of herbal medicine, or related areas.
Preferably with a degree in pharmaceutical sciences, or related areas.

iii **Necessary documentation**

- a) document proving the date of birth;
- b) document(s) proving the qualifications required in the Announcement for access to the course, if applicable;
- c) document proving the IBAN of the bank account held by the candidate, in which the name of the holder is mentioned;
- d) proof of residence permit, in the case of foreign students;
- e) document with tax identification number, in the case of foreign students;
- f) if applicable, proof of unemployment;
